Sevenson Environmental Services Inc. Pledger Creek Remediation Project

Repeat WEDA Safety Excellence Award winner Sevenson Environmental has done it again with their Pledger Creek Remediation Project.

They staffed the project with 25 on-site personnel and 15 pieces of heavy civil and marine equipment including excavators, dozers, push boats, scows, and 2 floating work platforms.

The project's location near and sharing roadways with an active manufacturing plant and Geotube® Dewatering operations presented continuously fluctuating high-hazard conditions. Dewatering gallery adaptations included ramps, a perimeter berm, site walks following new bag installations, and aluminum pick boards with handrails. Sevenson cited communication - early, often, and throughout the process - as a primary key to success.

Pledger Creek Remediation Project encompassed 66,304 total working hours with zero recordable injuries and zero negative impacts to the environment.
