The objectives of the meeting were to review progress on actions identified in the June 2001 meeting and to identify and initiate new actions relative to environmental issues related to dredged material management and marine transportation.

Craig Vogt reported that he had prepared and presented on June 13, 2002, to the WEDA Board of Directors the WEDA Environmental Commission Annual Report, which is attached. During the Board of Directors meeting, Craig Vogt requested approval to change membership on the Commission, such that the member representing the Environmental Interest Groups would be on an annual rotating basis from the locality of the annual WEDA Conference. This change was needed because the environmental interest groups that have been represented on the Commission have not been able to travel to the meetings because of limited availability of travel funds. The WEDA Board of Directors approved this change.

Bob Engler, Chair of the PIANC Environmental Commission (EnviCom), reported on EnviCom activities related to WEDA needs. He noted that a half dozen PIANC Working Group reports are available that are directly related to dredging. The EnviCom 2001 Annual Report is attached to this meeting summary.

Action Agenda Items

Curriculum. The discussion of this action item was limited as Beverly Fedorko was unable to attend this year's meeting. However, Bob Engler reported that the Corps of Engineers environmental education website on dredging and dredged

material management was up and has been extremely popular in its first few months of operation (http://education.wes.army.mil). Comments received from WEDA Environmental Commission members were incorporated into the website. A link on the WEDA website should be made to the environmental education Corps website.

Bob Engler mentioned that Beverly Fedorko had made progress in environmental education in the NY/NJ area and was active with various groups. We hope to hear more from Beverly during the year on progress and any needed future actions.
